Maryland's State House is the oldest state capitol in continuous legislative use, dating to 1772. Completed in 1779, it was the site of nationally important events during the American Revolution, including George Washington's resignation as commander in chief of the Continental Army, and the ratification of the Treaty of Paris. The capitol has the distinction

of being topped by the largest wooden dome in the United States constructed without nails. Renovation of the Rotunda, Archives Room, and Old House of Delegates Chamber has just been completed.
