The Mid-Point Assessment & Phase III WIPs

Part I: A Timeline of Actions and Decisions

The Chesapeake Bay TMDL requires that all practices are in place by 2025; thus, in 2018, following the mid-point assessment Bay jurisdictions will prepare the final Phase (III) of Watershed Implementation Plans (WIPs). Staff will provide an overview of the anticipated timeline. During 2016 and 2017, Commission staff will offer updates at each quarterly meeting on key actions and decisions leading up to the Phase III WIPs.

Part II: The Lead Clean Water Systems Integrator

By mid-2017, an updated computer model, designed to integrate the effects of climate change, Conowingo Dam, new land use and dozens of newly eligible or revised BMPs will be completed. In 2017, EPA will work with the jurisdictions to develop targets and expectations for the Phase III WIPs. The Commission asked Nick DiPasquale, Director of the Bay Program, “Who will serve as the lead systems integrator for the complex web of decisions, data and tools underway for the final phase of Bay restoration?” Staff will provide an overview of Mr. DiPasquale’s feedback.

Part III: Commission Engagement in the Final Phase of Restoration

Our Chairman will lead a discussion among Commission members of the specific aspects of the mid-point assessment and Phase III WIP development process that warrant its engagement.
