MEETING THEME: HEART OF THE CHESAPEAKE

Located almost precisely in the middle of the Chesapeake Bay, the low-lying marsh islands of the Chesapeake offer a perspective rarely seen or experienced by most. It is here where true ecosystem response to the many upstream restoration efforts can be measured and assessed. Three of the primary critical indicators of the Bay's health – blue crabs, oysters, and underwater grasses – naturally abound in the shallow waters surrounding these islands. A fourth – the unique and storied island waterman community – equally measures the results of our upstream policies. Our time at Port Isobel, directly adjacent to the waterman community of Tangier Island, Virginia, will give us a more pragmatic and tangible understanding of the current status of some of the Bay's key health indicators, and will bring us closer to the heart of a national treasure.

In May, the Chesapeake Bay Commission, along with the State of Maryland and the Commonwealth of Virginia, petitioned the U.S. Secretary of Commerce to declare a commercial fishery disaster for the blue crab. On Tuesday, September 23, that declaration was granted effectively taking another step towards potential economic assistance for watermen and seafood processors. We will get an update as to the status of the request, and discuss next steps with some of the Tangier Island community leaders.

NEW MODEL: BRINGS US DOWN TO THE LOCAL LEVEL
