*In 1906, Pierre S. du Pont purchased a farm to preserve a 15-acre arboretum that had been established by the previous owners. He would soon add gardens and greenhouses for his own and the public's enjoyment. Today the property has grown to more than 1,100 acres showcasing horticulture, architecture, art, and environmental sustainability with over 1.5 million visitors each year. Additionally, educational programs are offered for students from K-12 to graduate students as well as continuing education for horticulture and landscape professionals. An ambitious \$250 million expansion, "Longwood Reimagined," has just been completed, featuring 17 acres of new buildings and gardens opening to the public on November 22nd.*

**9:30 A.M. MANAGING A “MANURESHED”**

*A “manureshed” is the land around a livestock farm where manure can be applied as fertilizer to redistribute nutrient loads and help achieve environmental and economic goals. Manureshed management promotes pathways that move nutrients from sources, areas with excess nitrogen and phosphorus, to sinks, land in need of extra nutrients. Can better manure policy reduce commercial fertilizer reliance and cut down on polluted runoff to local streams while supporting production?*
